5.12.16 closed meeting of the Parish Hall Committee considered our proposal to site the Kingsbury portacabin shop along the southern boundary of the car park - much preliminary work had been done and the village had asked for a Central site, Suggesting the car park.

Many other options had been explored by members of the Working Party with no success, leaving the PH car park as the best option

6.12.16 Official news from the secretary of the PH Committee that

The Parish Hall Committee met and discussed the proposal to site the portacabin (40 feet x 11 feet with additional width of 7'6" for a ramp) in the Parish Hall's car park. The need for a shop was supported but this particular proposal was rejected because of the kabin's large size which would result in a significant loss of parking space. However, the Committee is open to other proposals.

8.12.16 5 of Working Party met with Debbie Stewart our Plunkett representative to form an Action Plan and to start the process of writing a Business Plan and formalising Community Shares etc. We want to become full members of Plunkett So that we can come under their umbrella for Insurance, Rules, Financial indemnity etc. and this will be a one off payment of £550

Pledges = £16,390.00

David Plumerage (Chairman of shop group) who attended as a member of the public with Elly Babbage reported the supplying of newspapers from the barn at the ring of bells have been put on hold as the Smiths newspaper distributors require £995.00 to start up as a new concern, Cheriton Fitzpaine Community Shop will be setting up as a Community Benefit society in the new year and should be able to start papers then.
