1. Parishioners Questions. Clive Lawson reported on the lack of a bus service between Cheriton Fitzpaine and Tiverton and the general scarcity of bus services to the village, particularly of services returning here in the afternoon/early evening.

5. Roads and Footpaths.

5.1 Proposed diversion routes, have been amended following contact from the clerk.

5.2 Sign at Cheriton Cross, Cllr Metcalf pointed out the post needs replacing as well as the arms, CCllr Squires to chase this up.

5.3 Cllr Metcalf reported a parishioner's concern over gully cleaning, not being carried out often enough in certain areas causing flooding, clerk to identify where the problem is and report to roads and highways.

5.4 Mike Smith has been approached to provide a quote for clearing road by Bawn Cottage and path by church, if no more than £150.00 it has been agreed by the council the work can be carried out without going back to the next meeting. Visibility at Waterside and Rectory, reported to be very poor, clerk to contact Mike Smith to cut verge.

5.5 Roads and highways have come back re the Millennium Stone area, nobody seems to know who owns this. Highways have come back to us and in principle have no objections to us putting a garden around the Millennium stone as long as visibility is not obstructed. A parishioner in attendance, Anne Nixon, asked from the Garden Club as the clerk had approached them for ideas – they would like more information e.g. Plans, Maintenance, time scale it was agreed the Garden Club would come back with some plans at the October meeting.

5.6 Cllr Norton reported street light no 1 not working in Barry Close making it very dark on the corner, clerk to report street light to Customer Service Centre on 0345 155 1004.
